

GIRLS' FOOTBALL IN SCHOOLS NEWSLETTER - MONTHLY PRIZE DRAW

Prize Draw Terms & Conditions

1. Eligibility

- 1.1. This prize draw is open to all school-based users registered on the Girls' Football in Schools website and subscribed to the e-newsletter found here: <https://girlsfootballinschools.org/newsletter.php>

2. Prize Draw Entry Period

- 2.1. This is a monthly prize draw with the winner drawn on the penultimate Friday of each month. Every eligible school will be entered into each monthly prize draw. Draws will take place monthly from October 2021 to June 2022.

3. Entry Requirements

- 3.1. To enter this prize draw, school-based users, registered on the Girls' Football in Schools website, must have signed up to receive the Girls Football in Schools e-newsletter.

4. Winner selection, notification and prizes

- 4.1. The winning school will be randomly selected by the Youth Sport Trust from all eligible entries on the date of each prize draw.
- 4.2. The winning school will be notified by email, 3 days after each draw.
- 4.3. If the winning school does not respond within 7 days after they have been notified of winning or is not able or available to accept the prize for any reason which is beyond the Promoter's reasonable control, then the Promoter reserves the right to award the prize to another eligible school.
- 4.4. The prize is as follows:

5. Data Protection

- 5.1. By entering this prize draw, you agree that, if your school is the winner, the Promoter may make your school name available and may use your school name for publicity purposes without additional remuneration.
